Jade Yoga Kripalu Weekend Retreat Scholarship Rules 2017

ELIGIBILITY

The scholarship is open to all woman over 18 years of age who have been diagnosed with fallopian tube or ovarian cancer.

SPONSOR

The Kripalu R&R retreat package is sponsored by Jade Yoga International (Sponsor) located in Conshohocken, PA, and Dara's Defense located in Wallingford, PA.

AGREEMENT TO OFFICIAL RULES

Participation in this scholarship constitutes full and unconditional agreement and acceptance of the rules and decisions of the sponsor. All decisions are final and awarding of this scholarship is contingent upon compliance with rules and all other requirements set forth herein.

APPLICATION PERIOD

Applications will be accepted until 12:00 am EST until May 15, 2017. No entries received after 12am EST on May 15, 2017 will be considered. Recipient of the Kripalu R&R weekend will be selected by the Dara's Defense Selection Committee and notified via email or telephone before May 30, 2017.

HOW TO ENTER

Applicant must complete application and send to address below by designated deadline. Applicant must not have received any other direct grants from a nonprofit related to their diagnosis.

RECIPIENT NOTIFICATION

The recipient will be notified via telephone or email on May 30, 2017. Instructions for using the scholarship will be discussed with the winner. The recipient will be announced at the FU Cancer MusicFest in Mt Airy, PA on June 3, 2017. If the recipient cannot be contacted within five (5) days after May 30th, another recipient may be chosen.

Once notified, recipient shall be required to sign a Declaration of Compliance within ten (10) days. Awarding of this scholarship is based on compliance with conditions set

forth in this document. Scholarship must be used within 2 years of issuance. Jade Yoga and Dara's Defense reserve the right to suspend or terminate this scholarship award in the event the contest is impaired or compromised for any reason including but not limited to fraud and technical problems.

SCHOLARSHIP

This scholarship is for a 3 day, 2 night R & R Retreat package for two to the Kripalu Center for Yoga & Health in Stockbridge, Massachusetts. The scholarship includes accommodations at Kripalu, Kripalu's delicious all-natural meals, optional Kripalu faculty-led workshops and guided outdoor activities, daily yoga and noon dance classes, evening events and use of Kripalu amenities including sauna, fitness room, private lakefront beach, walking and hiking trails and more. A small stipend for travel is included in the scholarship.

RELEASE AND LIMITATIONS OF LIABILITY
