

Dara's Defense JadeYoga Kripalu Retreat Scholarship Information & Rules

SCHOLARSHIP

The scholarship is for a 3 day, 2 night R & R Retreat package for two(2) to the Kripalu Center for Yoga & Health in Stockbridge, Massachusetts. The scholarship includes accommodations at Kripalu, Kripalu's delicious all-natural meals, optional Kripalu faculty-led workshops and guided outdoor activities, daily yoga and noon dance classes, evening events and use of Kripalu amenities including sauna, fitness room, private lakefront beach, walking and hiking trails and more. A small stipend for travel is included in the scholarship.

- Dara's Defense will be accepting nominations for this scholarship throughout the year and will be awarded annually
- The recipient will be notified by email or telephone by May and announced at the annual Dara's Defense Music Festival held in June, of each year.

ELIGIBILITY

The scholarship is open to all women over 18 years of age who have been diagnosed with fallopian tube or ovarian cancer.

- Must be nominated by an Oncology/Medical Team Member, which includes MD, RN, Social Worker, Psychologist, or Patient Navigator
- Confirmed diagnosis of fallopian tube or ovarian cancer and must be in active treatment within the past 2 years (chemotherapy, radiation and or surgery).
- Preference is given to candidates residing in the USA in the following states: PA, NJ, NY, DE, and MD. However, candidates residing outside of the country or these states will be considered.
- If candidate is under 21 years of age, they must travel with a parent or guardian.
- Must not have received any other direct scholarships or grants from a non-profit related to their diagnosis within the past 3 years.

SPONSOR

The JadeYoga Kripalu Retreat Scholarship is sponsored by JadeYoga International located in Conshohocken, PA, and Dara's Defense Organization located in Wallingford, PA.

AGREEMENT TO OFFICIAL RULES

Participation in this scholarship constitutes full and unconditional agreement and acceptance of the rules and decisions of the sponsor. All decisions are final and awarding of this scholarship is contingent upon compliance with rules and all other requirements set forth herein.

NOMINATION PROCESS

Candidate must be nominated by an Oncology/Medical Team Member, which includes RN, MD, Social Worker, Psychologist, or Patient Navigator.

- Oncology Team Member will complete nomination form and send via mail or email.
- Candidate will agree to be interviewed by a Dara's Defense Selection Committee member to determine that all criteria is met prior to granting scholarship.

RECIPIENT NOTIFICATION

Recipient of the Scholarship will be selected by the Dara's Defense Selection Committee and notified by email or telephone by May and announced at the annual Dara's Defense Music Festival held in June, of each year.

Once notified, recipient shall be required to sign a Declaration of Compliance within ten (10) days. Awarding of this scholarship is based on compliance with conditions set forth in this document. Scholarship must be used within 2 years of issuance.

JadeYoga and Dara's Defense reserve the right to suspend or terminate this scholarship in the event the program is impaired or compromised for any reason including but not limited to fraud and technical problems.

RELEASE AND LIMITATIONS OF LIABILITY

By participating in this scholarship process candidates agree to release and hold harmless JadeYoga, Dara's Defense and each of their respective officers, directors and representatives from any claim or cause of action arising out of participation in this scholarship process or receipt or use of the R&R retreat weekend at Kripalu (including any travel or activity related thereto) including but not limited to: internet problems, unauthorized human intervention, printing problems or typographical errors, cancellation or postponement of event. Candidate/recipient further agrees that in any cause of action, JadeYoga and Dara's Defense shall not be liable for any expenses, including attorney's fees. Candidate/recipient waives the right to claim any damages whatsoever including, but not limited to, punitive, consequential, direct or indirect damages.

DISPUTES

Any disputes shall be resolved in Delaware County, Pennsylvania and governed by the laws of Pennsylvania.
